

KENTUCKY SPRING PREMIER GUIDELINES FOR COVID-19

The Kentucky Spring Premier has set the following guidelines to conduct this competition during the COVID-19 pandemic to help prevent illness and to avoid being exposed to the virus (see www.cdc.gov). Additionally, all Federal, State and Local laws that may be applicable must be followed. Failure to follow these guidelines may result in expulsion from the show grounds.

In consideration of being allowed to participate at and to be on the grounds of the 2020 Kentucky Spring Premier Horse Show, all participants, their agents, staff and any family members present agree that:

1. Participation includes possible exposure to and illness from infectious diseases including but not limited to MRSA, influenza, and COVID-19. While particular rules and personal discipline may reduce this risk, the risk of serious illness and death does exist; and,
2. YOU KNOWINGLY AND FREELY ASSUME ALL SUCH RISKS, both known and unknown, EVEN IF ARISING FROM THE NEGLIGENCE OF THE RELEASEES or others, and assume full responsibility for your participation; and,
3. YOU willingly agree to comply with the stated and customary terms and conditions for participation as regards protection against infectious diseases. If, however, you observe and any unusual or significant hazard during my presence or participation, YOU will remove yourself from participation and bring such to the attention of the nearest official immediately; and,
4. YOU, for yourself and on behalf of your heirs, assigns, personal representatives and next of kin, HEREBY RELEASE AND HOLD HARMLESS Kentucky Spring Premier Horse Show, the Mercer County Fairboard, and Mercer County Fairgrounds, their officers, officials, agents, and/or employees, other participants, sponsoring agencies, sponsors, advertisers, and if applicable, owners and lessors of premises used to conduct the event ("RELEASEES"), WITH RESPECT TO ANY AND ALL ILLNESS, DISABILITY, DEATH, or loss or damage to person or property, WHETHER ARISING FROM THE NEGLIGENCE OF RELEASEES OR OTHERWISE, to the fullest extent permitted by law.

SPECTATORS

1. **NO GENERAL PUBLIC** allowed on competition grounds
2. Family member of exhibitor only
3. Are not allowed in the barn, except one family member with a juvenile rider before class
4. Not to form a group of more than 10 people in the stands
5. Maintain social distancing of 6 feet in the stands
6. Use trash receptacles to avoid others coming into contact with contaminated items not discarded properly.
7. Avoid touching eyes, nose, mouth and face.
8. Must wear mask in the presence of others if not a family member.
9. Owner of entry that is showing with another person showing that entry are allowed for the relevant class only.

BARNS

1. Trainers and/or grooms only allowed in the barns before show time
2. Exhibitor only before scheduled class, juvenile may have one family member
3. Groups of no more than 10 in the barn area
4. Use trash receptacles to avoid others coming into contact with contaminated items not discarded properly.
5. Avoid touching eyes, nose, mouth and face
6. Wash hands and wear gloves whenever possible
7. Clean and disinfect tack, equipment and surfaces others might come in contact with.
8. Must wear mask in the presence of others if not a family member.

OFFICE

1. Submit entries online or by email to loriluvshorses@yahoo.com
2. Office appointments for check-in/picking up numbers/add-scratch/closeout are to be made at <https://square.site/book/7AK55JPM8F8ZB/kentucky-spring-premier-horse-show-harrodsburg-ky>.
3. Mask must be worn when at the office and in the presence of others
4. All scratch and adds must be made either electronically or by appointment at the office
5. Must stand 6 feet from each other in line to the office; areas will be marked accordingly
6. Hand sanitizing stations will be in and/or around the office
7. Use trash receptacles to avoid others coming into contact with contaminated items not discarded properly.
8. Avoid touching eyes, nose, mouth and face
9. Wash hands and wear gloves whenever possible

MAKE UP AREA

1. Only trainer, groom and exhibitor allowed in this area
2. Maintain 6 feet between each group
3. Mask should be worn, except exhibitor when on horse
4. Only those preparing for the class that is to be held next allowed in make-up ring
5. Wait for the class leaving the ring to be clear before going to enter the ring
6. Use trash receptacles to avoid others coming into contact with contaminated items not discarded properly.
7. Avoid touching eyes, nose, mouth and face

RING

1. Maintain 6 feet between trainers in the ring or on the rail
2. When leaving ring maintain social distancing
3. Ribbons will be placed outside the ring and are to be picked up when leaving the ring
4. Use trash receptacles to avoid others coming into contact with contaminated items not discarded properly.
5. Avoid touching eyes, nose, mouth and face

IN GENERAL

1. Limited food concession service
2. Hand sanitizing stations in office, barns, make-up ring, and ring
3. Please park in designated parking area and 6 feet apart
